

# The Aspen Tech Policy Hub: 5 Years of Impact

Over the last 5 years, the Aspen Tech Policy Hub has trained more than 550 science and technology experts on how to impact policy. We have seen more than 100 alumni transition into the public sector, and have celebrated our alumni directly influencing policy more than 40 times. As we grow and expand our impact as the newly launched Aspen Policy Academy – equipping a broader array of science, technology, environmental, and nonprofit leaders with policy skills – we reflect on the ways our staff and alumni have tackled society’s most pressing challenges since our founding.

We seek three types of impact from our work:

- Guiding our alumni’s careers toward policy work,
- Improving policy outcomes, and
- Making better resources for policy training available.

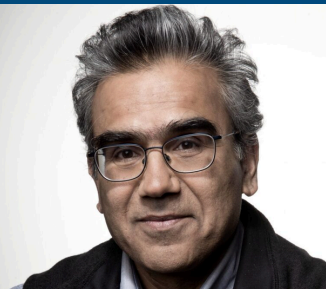

### Advancing Cybersecurity On a National Level
